- To contribute to marking, assessment and examinations and provide feedback to students
- Act as personal tutor to a group of students.

- Undertake individual or collaborative projects of relevance to the School/University
- Extend, transform and apply knowledge acquired from scholarship to learning and teaching
- Write or contribute to publications in peer reviewed academic journals or disseminate research findings using other appropriate media
- Make presentations at conferences or exhibit work in other appropriate events, participating in dissemination and engagement activities to contribute to knowledge base of area of expertise, maximise policy, media industrial or community impact of scholarship.
